District Scout Adventure Day Saturday 6th July 2024 at The District Activity Centre, The Canyon

Calling all Scouts for a day of adventure at the Canyon.
The following should be available (subject to availability):

Climbing, Abseiling, Shooting, Archery

The day runs from 9:30am through to 3:00pm with a break for lunch (bring your own packed lunch) and costs £11. To take part, please complete the two forms (general permission and shooting consent) and return with your payment by no later than Monday 1st July 2024. The forms and payment can be returned via your Scout leader, to the Scout shop at the District Scout HQ, Poplars on Monday evenings between 7:30pm and 8:30pm (please use an envelope and label for the attention of Neil Ravilious) or via post to the address above. More details and a kit list can be found below. Due to the number of participants allowed on some of the activities we may need to limit numbers. Although unlikely, if we do, places will be allocated on a first-come, first-served basis. Return promptly to ensure a place.

Arrangements for the day

9:30am Saturday 6th July, Stevenage Scouts Activity Centre, The Canyon, Valley Way, SG2 9AF. Please check-in and collect information on your activity session times. You will need the kit listed below and a **packed lunch**. Squash will be provided. There is a public car park adjacent to the Pear Tree pub, another opposite at the shops or in Valley Way itself. If there isn't sufficient car parking, you can also park at the 'Show Ground' and walk across the field to the Canyon.

3:00pm Saturday 6th July, Stevenage Scouts Activity Centre, The Canyon, Valley Way, SG2 9AF. Please arrange to be picked up from here after you have signed out.

Activity groups are arranged before the event to ensure an efficient start (maximising on activity time). Please don't ask to change groups on the day. **You may e-mail Neil no later than Monday 1st July, using the e-mail address above, to suggest another Scout attending, who you would like to be in the same group as yourself.**

We plan to provide 4 one-hour sessions of activities along with 15 minutes to get set-up and complete safety briefings. Activities may have to be adapted if the weather is unsuitable or we are short of activity instructors on the day, but we will do everything possible to ensure you have a good day! A 30-minute break will be provided for you to eat your **packed lunch (which you must supply!)**. Please do not plan to leave the Canyon at lunch-time.

Suitable activity clothing for weather (not uniform), but wear Troop Scarf.	Footwear with a full sole (trainers or walking shoes). No sandals or crocs.	Packed lunch and drink.
A waterproof jacket.	Sun cream & sun hat.	Suitable bag to carry your kit in!
